Anyone who pays Arizona income tax may be eligible for the tax credits in a collective amount up to your total tax liability.

- SAY supports nearly 100 youth programs and generates almost \$2 million annually in tax credit donations.



## Why Support Arizona Youth?

### NEED

Arizona continues to rank among the worst states nationally for child well-being and 46th in the most recent Kids Count Survey by the Annie E. Casey Foundation. SAY donations positively impact our most vulnerable populations and most pressing youth issues.

### EFFICIENT

100% of donated funds go to Qualified Charities and Foster Care Charities.

### CHOICE

Through SAY, you can select "Highest Need" to have the greatest impact or indicate your preference for a specific qualified charity.

### FLEXIBLE

Donation deadline is now extended to Tax Day. You can support both the charitable tax credit & foster care tax credit through SAY.

### Take advantage of the Arizona State Tax Credit to help us make a brighter future for nearly 100,000 local youth through SAY!

Arizona tax law allows those who donate through a qualifying umbrella organization like Executive Council Charities SAY, LLC to receive a maximum tax credit of \$800 for joint filers and \$400 for single filers (or married filing separately) when contributions are directed to Qualifying Charities (QC) and an **additional** maximum tax credit of \$1000 for joint filers and \$500 for single filers (or married filing separately) when contributions are directed to Qualifying Foster Care Charities (QFCC).
