### Take advantage of the Arizona State Tax Credit to help us make a brighter future for nearly 100,000 local youth through SAY!

Arizona tax law allows those who donate through a qualifying umbrella organization like Executive Council Charities SAY, LLC to receive a maximum tax credit of \$800 for joint filers and \$400 for single filers (or married filing separately) when contributions are directed to Qualifying Charities (QC) and an <u>additional</u> maximum tax credit of \$1000 for joint filers and \$500 for single filers (or married filing separately) when contributions are directed to Qualifying Foster Care Charities (QFCC).

#### **MAX YOUR TAX CREDIT**

Single Filers

\$400 to QC & \$500 to QFCC

Joint Filers

\$800 to QC & \$1000 to QFCC
